INSTRUCTIONS FOR AUTHORS SUBMITTING THE EXTENDED ABSTRACTS FOR YOCOCU 2016, INTERNATIONAL CONFERENCE TO BE HELD AT MUSEO NACIONAL CENTRO DE ARTE REINA SOFIA (HEREAFTER MNCARS, FROM 21st TO 23rd SEPTEMBER 2016.

DEADLINE FOR SUBMISSION OF MANUSCRIPTS IS 25th JULY 2016.

PREVIOUS CONSIDERATIONS:

Only original, unpublished and up-to-date texts will be published.

The official language of the conference is English; therefore, texts written in any other language will not be considered.

The Scientific Committee of the conference will select the contributions to be published, among those submitted by the authors, according to their scientific quality and their adherence to the guidelines provided in the following Instructions for Authors. The signing of the authorization and copyrights license, provided by MNCARS, is mandatory.

By signing this document the author:

- transfers non-exclusively the copyright of the text and other original material provided for the publication,
- authorizes its reproduction, distribution and public communication on printed and digital media, such as publications (catalogues, brochures, press releases, etc.), CD-Rom, DVD, MNCARS website, as well as its possible use in presentations, activities or exhibitions organized by MNCARS, always with cultural and non-profit purposes.

MNCARS intends the publication and all its contents, including the texts and any other material, to be licensed under the terms and conditions of a Creative Commons license; specifically the "Attribution - Non-commercial - No Derivative Works 4.0 - Spain" Licence (CC BY-NC-ND 4.0 ES), in order to facilitate and promote their dissemination.

EXTENDED ABSTRACT SUBMISSION. INSTRUCTIONS FOR AUTHORS:

The manuscript and related files will be submitted through a big file transfer service (preferably **Wetransfer**, www.wetransfer.com). Files will be named with the first author surname.

It is recommended to structure the manuscript in the following sections:

INTRODUCTION (background, state of the art, motivation of the contributions, aims/objectives, hypothesis, location of the artwork, etc)

METHODS & METHODOLOGY (how the study was performed, means, techniques)

RESULTS & DISCUSSION

CONCLUSIONS

Acknowledgements - if appropriate - (especially helpful people, institutions, funding, grants, projects, etc)

THE SUBMISSION WILL BE STRUCTURED IN TWO FOLDERS:

FOLDER 1: MS WORD (NOT PDF) FILE WITH THE FOLLOWING ORDER AND STRUCTURE:

.- **Title:** 100 characters maximum, including spaces, capital letters, bold, Arial font, 14 points size, single spacing.

.- **Authors:** First name (and middle name, if any), and last name-s or surname-s. Arial font, 14 points size

.- **Affiliations, capital letters, Arial 12 pt. Include only institution, city and country.**

.- Body of the text: 1500 words, maximum (consider that this document contains <1500 words, as an example).

.- Typography: Arial font, 12 points size, 1.5 spacing.

.- Indication of images and tables: no images will be included in this Word manuscript, no layout is required.

Reference to images and tables will be in numerical order (always in Arabic numerals - 1, 2, 3 ...), and between parenthesis, preceded by the abbreviation "Fig." or "Table", whichever applies, with the following format: (Fig.01) (Fig.02), etc.

.- References and notes. The reference/notes list will be placed at the end of the manuscript and numbered (Arabic numerals: 1, 2, 3...). In the body of the text, the references will be cited with correlative superscript numbers placed wherever it

corresponds. References should be placed always before punctuation marks (except for question or exclamation marks).

.- **Bibliography:** guidelines for the bibliographical reference list are provided below. For citing bibliographical references in the body text, use superscript Arabic numbers (¹, ², ³) and include the reference in a numbered footnote (Chicago-Style Citation).

.- **Short summary of the currículum vitae:** 5 lines, maximum.

BIBLIOGRAPHY

Bibliography will appear as footnotes. When a source has multiple editions, edition consulted by the author will be the one included in the bibliography, and it will be formatted as follows:

.-Books, catalogues and monographs:

Author (Last name-s, initial of the first name), *Title*, City of publication, Publishing house, year, page (if appropriate).

- If it is an exhibition catalogue, include **[cat. exh.]** at the end of the bibliographical reference.

Example:

Feilden, B.; Jokilehto, J., *Guidelines for World Cultural Heritage Sites*, Rome, ICCROM, 1993.

- When there are more than 4 authors, only the last name and initial of the first author is required, followed by the abbreviation **et al.**

.-Journals and periodical publications:

Author (Last name-s, first name initial), "Paper title", *TName of the journal or publication*, number/volumen or collection/number or volume/fascicle, date/year, pages.

Example:

Oesch, S. and Faller, M., "Environmental effects on materials: the effect of the air pollutants SO₂, NO₂, NO and O₃ on the corrosion of copper, zinc and aluminium. A short literature survey and results of laboratory exposures", *Corrosion Science*, n. 39, Vol. 9, 1997, pp. 1505-1530.

.- Magnetic or electronic supports:

Works magnetically or electronically recorded (magnetic and recording tapes, diskettes, CD and CD-ROM).

Mention has to be made to: Author or entity responsible of the content, *Title*, type of Support, Edition, City of edition, year of edition.

Example:

Harper, D. et al., *Landscape Restoration Handbook*, CD-ROM, Florida, 1999.

.-References from the web:

When citing a website, the author or entity/institution responsible for the content must be shown, together with the Title, full web link, and [date of access]

Example:

ICOMOS, *Illustrated glossary on stone deterioration patterns*,
http://www.icomos.org/publications/monuments_and_sites/15/pdf/Monuments_and_Sites_15_ISCS_Glossary_Stone.pdf [23-05-2016].

FOLDER 2: IT WILL CONTAIN IMAGES, GRAPHS AND TABLES:

.- **Images:** a maximum of 3 images will be saved (in JPG or TIFF format) separately and numbered in a folder, named Figure01, Figure02, Figure03. Minimum resolution accepted is 400 dpi, with a maximum size of 15 cm x 21 cm. MNCARS reserves the right to not publish them when not fulfilling the requirements here described and on the basis of the global needs of the publication.

.- **Images reproduction rights:** Only images free of copyright and whose reproduction rights have been granted for free.

The use of images of artworks subjected to payment of reproduction rights should be avoided, especially if they are not essential for the understanding of the text. MNCARS reserves the right of not including them if this is the case.

A clear reference to the image origin must be provided, indicating the source -author, title - if appropriate-, image owner, photographer name - if appropriate-. Images must be properly identified so that MNCARS can check the corresponding reproduction authorizations from the owners of the intellectual property rights. All these issues should be referenced in the figure caption.

No images from internet will be accepted unless they fulfil with the required quality criteria and with those requirements already mentioned for their reproduction.

.- **Figure captions:** A Word file (not PDF, please) containing the list of the figures (Fig.01, Fig.02, Fig.03). Graphs will be considered as figures; save the graphs with the size they should be published, considering that the lettering must be clearly readable and the lines width enough to be clearly visible.

.-**Tables:** each table (a maximum of two are allowed) will be saved separately in files named Tab.01, Tab.02, citing them in the body text to better allocate them. Maximum size for tables is the same than for images/figures. Use only horizontal lines (not vertical), and Arial font, 10 points size.

MNCARS reserves the right to design the graphics in the publication and to do them according to the submitted data, always respecting the data content.

Example of a table format:
